GUIDE TO INFORMATION AVAILABLE THROUGH THE MODEL PUBLICATION SCHEME 2015

The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- publish the classes of information that they make routinely available
- tell the public how to access the information and what it might cost.

Edinburgh Innovations Limited (“the company”) has adopted the Model Publication Scheme 2015 produced by the Scottish Information Commissioner. This scheme was last reviewed and updated in March 2021.
